Privacy Policy 2021

Effective date: June 1, 2018, Updated December 30, 2023.

Amplepack operates both Web based applications and Mobile based applications (The "Service").

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use our Service and the choices you have associated with that data.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. Unless otherwise defined in this Privacy Policy, terms used in this Privacy Policy have the same meanings as in our Terms and Conditions.

Information Collection and Use

We collect several different types of information for various purposes to provide and improve our Service to you or interact with our customer to serve with high dignity.

Types of Data Collected

Personal Data

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

- Email address for contacts
- · First name and last name for confirmatory and abuse monitoring
- Phone number for registration of our service and security controls
- Cookies and Usage Data for monitoring service usage

Usage Data

We may also collect information that your browser sends whenever you visit our Service or when you access the Service by or through a mobile device apps ("Usage Data").

This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, Mobile Phone device, version, the pages of our Service that you visit, the mobile application log time and date, the time spent on those pages, unique device identifiers and other diagnostic data.

When you access the Service by or through a mobile device, this Usage Data may include information such as the type of mobile device you use, your mobile device unique ID, the IP address of your mobile device, your



mobile operating system, the type of mobile Internet browser you use, unique device identifiers and other diagnostic data.

Tracking & Cookies Data

We use cookies and similar tracking technologies to track the activity on our Service and hold certain information.

Cookies are files with a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyze our Service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.

Examples of Cookies we use:

- Session Cookies. We use session Cookies to operate our Service.
- **Preference Cookies.** We use Preference Cookies to remember your preferences and various settings.
- **Security Cookies.** We use Security Cookies for security purposes.

Use of Data

Amplepack uses the collected data for various purposes:

- To provide and maintain the Service including the ability to log in to our services
- To notify you about changes to our Service
- To allow you to participate in interactive features of our Service
- To provide customer care and support
- To provide analysis or valuable information so that we can improve the Service
- To monitor the usage of the Service
- To detect, prevent and address technical issues

Transfer of Data

Our Client's information, including Personal Data, will not be transferred to — and maintained on — computers located outside of our country, state, province, or other governmental jurisdiction where the data protection laws may differ from other jurisdictions.

If you are located outside Tanzania and choose to provide some information to us, please note that we won't store or keep data, including Personal Data, to Tanzania and process them there.
